□ A copy of the conveyance document (i.e., warranty deed, quitclaim deed, court decree, contract of sale, etc.) that includes a legal description of the property or a description of the water right(s) if no land is conveyed.

□ Plat/survey map or aerial photograph that clearly shows the place of use and point of diversion for each water right listed above in Item #1.

□ Filing fee:

- \$25.00 per undivided water right
- \$50.00 per divided water right
